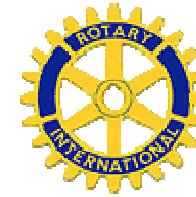

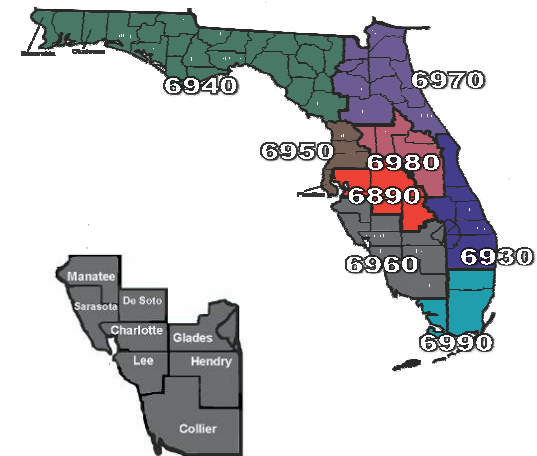

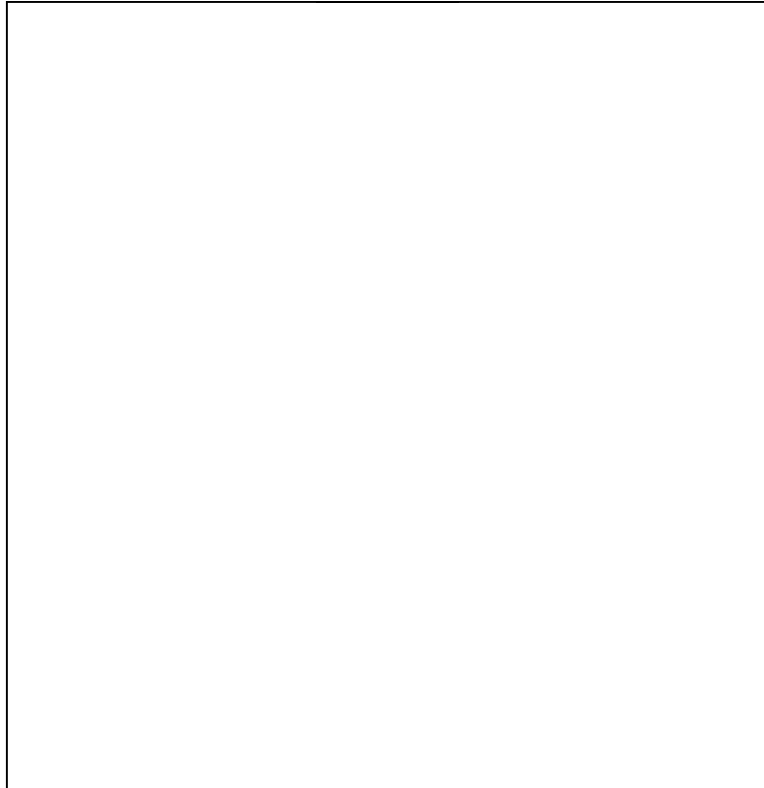

## Paul Harris, Founder of Rotary

Paul P. Harris, the founder of Rotary, was born in Racine, Wisconsin, U.S.A. on April 19, 1868. He received the bachelor of physical culture and LL.D degrees from the University of Iowa, and an honorary Ph.D. in 1933 from the University of Vermont. The Boy Scouts of America gave him the Silver Buffalo Award, and he was decorated by the governments of Brazil, Chile, Dominican Republic, Ecuador, France and Peru.



### Some Interesting Facts about Paul Harris and Rotary

- Paul Harris was a lawyer in Chicago
- Met with three men, Silvester Schiele, a coal dealer; Gustavus Loehr, a mining engineer and Hiram Shorey, a merchant tailor to form what is known today as Rotary
- The first meeting was on February 23, 1905
- Rotary began as an idea more than 100 years ago. Today, Rotary flourishes worldwide with 1.2 million members in more than 200 countries and geographical areas.
- By 1921, Rotary clubs had been formed on six continents.
- By 1925, Rotary had grown to 200 clubs with more than 20,000 members
- In 1932, Rotarian Herbert J. Taylor created The Four-Way Test, a code of ethics adopted by Rotary 11 years later. The test, which has been translated into more than 100 languages, asks the following questions:

Of the things we think, say or do

1. Is it the TRUTH?
2. Is it FAIR to all concerned?
3. Will it build GOODWILL and BETTER FRIENDSHIPS?
4. Will it be BENEFICIAL to all concerned?
